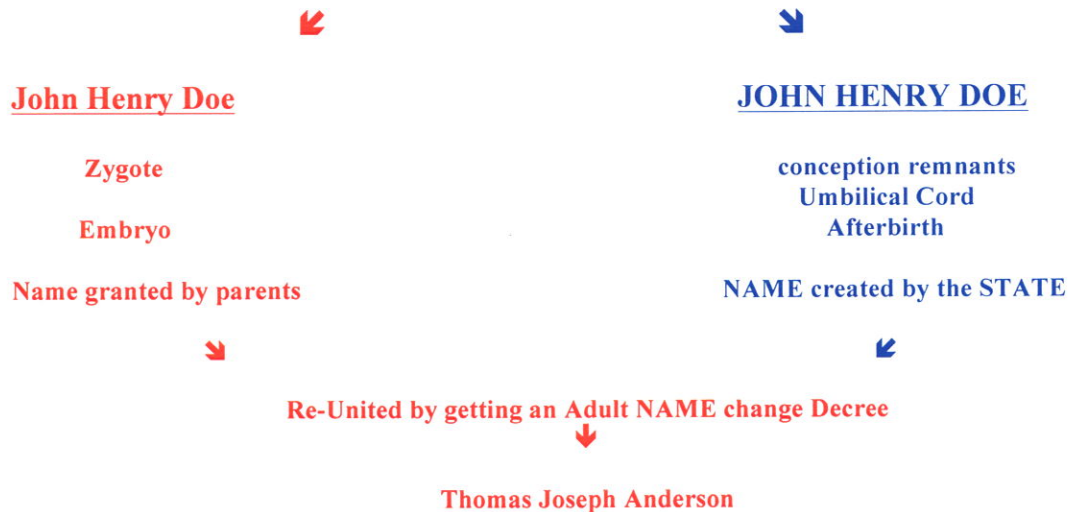

In Trust Law it is called The Doctrine of Merger

you are merging the 2 Titles (2 Trusts) together: when a higher right and a lower right over the same subject matter: the lower right is extinguished, when a Beneficial Right by Nature of a living man claims the beneficial right of a legal fiction over the same subject matter; The higher right wins because rights by nature trump rights by legal. Shit happens behind the scenes in the gov't computers, once you do the NAME change and notify the SSA. The other major thing that happens with the Decree is the **STATE created Strawman** without the real man surety **is now a dead entity**, not presumed dead, he is deceased. (No Surety)

Why does the Gov't give us COLB's with their agent's signature on it ?
Think of the **County** and **STATE COLB** as a receipt for groceries. It is evidence of property that is yours. If you forget a bag when you leave; you can go back and with the receipt prove the bag of groceries is yours. (GO BACK & CLAIM YOUR PROPERTY) !!!!

The County COLB : your mom & dad left the hospital but abandoned the Upper/lower case name there & then the name was registered at the County in the Sea Jurisdiction creating a Foreign Situs Trust. Vatican retains control of it until you come back to claim the property.

The STATE COLB: The Afterbirth is abandoned at the hospital, thus the (**born alive tissue is presumed to die**) so the **STATE gives it an ALL CAPS NAME**; again waiting for you (**the real man**) to come back & claim your property.
