**Trust Agreements:** a trust splits title of the asset into legal title and equitable title  
Collapse a Trust = merge the Legal and Equitable Titles or when a Beneficial Right by nature of a living man claims the beneficial right of a legal fiction by characteristic over the same subject matter

*legal name change*

**GRANTEE:** One who holds Allodial Root Title

**GRANTOR-** is the creator of the Trust, the Settlor furnishes the consideration and exchanges the property into the trust. The Grantor specifies the terms of the contract, (indenture-Type of Law), which governs the conduct of the Trustees, the privileges of the beneficiaries, and the duties and obligations of the Beneficiary

**TRUSTEE-** holds legal title to the trust assets. Holds controlling Interest over the res. The trustee (Fiduciary) carries out the conditions of the trust contract and is the protector for the property placed in the trust, He holds "Ownership" of the Asset he/she pays and/or settles all accounts or charges against the Trust. He/she defends the Trust in Court. (called the Defendant = defending the Trust)

**BENEFICIARY-** holds equitable title, he gets use and possession of the property in the trust. "Beneficial Owner" gets Privileges and Benefits, BUT has duties and obligations

**LAW FORM** - Creator decides what Type of Law to be used in the Trust.

**§ 7-201. Definitions.**

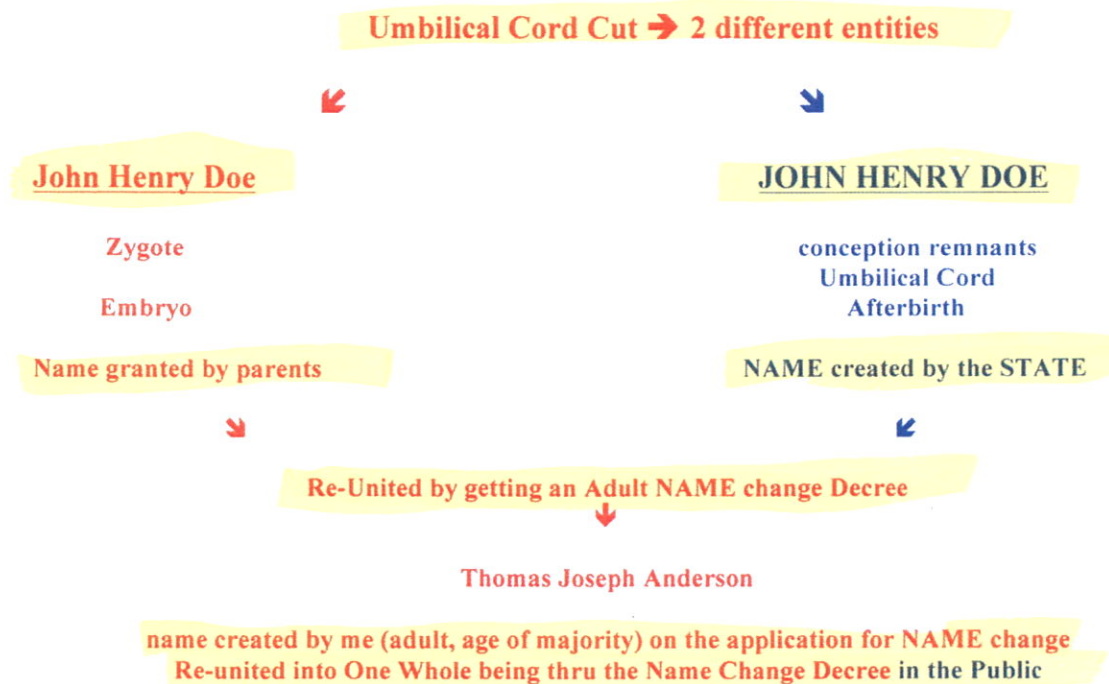
Unless otherwise specified as used in this chapter, the term:

- (1) "Court" means the Superior Court of the District of Columbia established by § 11-901.
- (2) "Day" means calendar day.
- (3) "Dead body" means a human body or such parts of such human body from the condition of which it may be reasonably concluded that death recently occurred.
- (4) "District" means within the geographical boundaries of the District of Columbia.
- (4A) "Domestic partner" shall have the same meaning as provided in § 32-701(3), but shall exclude a domestic partner who is the parent, grandparent, sibling, child, grandchild, niece, nephew, aunt, or uncle of a woman who gives birth to a child.
- (4B) "Domestic partnership" shall have the same meaning as provided in § 32-701(4), but shall exclude a domestic partnership where a domestic partner is the parent, grandparent, sibling, child, grandchild, niece, nephew, aunt, or uncle of a woman who gives birth to a child.
- (4C) "Expected death" means a death from a previously diagnosed illness with a prognosis of death in less than 6 months.
- (5) "Fetal death" means death prior to the complete expulsion or extraction from its mother of a product of a human conception, irrespective of the duration of pregnancy. The death is indicated by the fact that after such expulsion or extraction the fetus does not breathe or show any other evidence of life such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles. The term "fetal death" does not include an induced termination of pregnancy.
- (6) "File" means the presentation of a vital record for registration.
- (7) "Final disposition" means the burial, interment, cremation, removal from the District, or other authorized disposition of a dead body or fetus.
- (7A) "IV-D agency" means the organizational unit of the District government, or any successor organizational unit, that is responsible for administering or supervising the administration of the District's State Plan under title IV, part D, of the Social Security Act, approved January 4, 1975 (88 Stat. 2351; 42 U.S.C. § 651 et seq.), pertaining to parent locator services, paternity establishment, and the establishment, modification, and enforcement of support orders.
- (7B) "Gender identity or expression" shall have the same meaning as provided in § 2-1401.02(13A).
- (8) "Institution" means any establishment, public or private, which provides inpatient medical, surgical, or diagnostic care or treatment, or nursing, custodial, or domiciliary care, or to which persons are committed by law.
- (9) "Live birth" means the complete expulsion or extraction from its mother of a product of human conception, irrespective of the duration of pregnancy, which, after such expulsion or extraction, breathes, or shows any other evidence of life such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut or the placenta is attached.
- (10) "Person" means an individual, a trust, an estate, a partnership, a corporation (including associations, joint stock companies, and insurance companies), the District government, or an agency or instrumentality of the District government.

Crrow, I listened to Podcast # 195 with KK, he talked about when the umbilicus is cut, you have the embryo (fetus-child) left along with the Afterbirth, I drew a diagram as to what I do by going to Court and doing an Adult NAME change.

## it's always about going back & making the Claim



### In Trust Law it is called The Doctrine of Merger

you are merging the 2 Titles (2 Trusts) together: when a higher right and a lower right over the same subject matter: the lower right is extinguished, when a Beneficial Right by Nature of a living man claims the beneficial right of a legal fiction over the same subject matter; The higher right wins because rights by nature trump rights by legal. Shit happens behind the scenes in the gov't computers, once you do the NAME change and notify the SSA. The other major thing that happens with the Decree is the **STATE created Strawman** without the real man surety **is now a dead entity**, not presumed dead, he is deceased. (No Surety)

Why does the Gov't give us COLB's with their agent's signature on it ?  
Think of the **County** and **STATE COLB** as a receipt for groceries. It is evidence of property that is yours. If you forget a bag when you leave; you can go back and with the receipt prove the bag of groceries is yours. **(GO BACK & CLAIM YOUR PROPERTY) !!!!**

**The County COLB** : your mom & dad left the hospital but abandoned the Upper/lower case name there & then the name was registered at the County in the Sea Jurisdiction creating a Foreign Situs Trust. Vatican retains control of it until you come back to claim the property.

**The STATE COLB**: The Afterbirth is abandoned at the hospital, thus the **(born alive tissue is presumed to die)** so the **STATE gives it an ALL CAPS NAME**; again waiting for you **(the real man)** to come back & claim your property.
